Men's hockey team goes down 2-3

LONDON: The Indian Men's Hockey Team went down 2-3 against Germany in their third match of the London leg of the FIH Hockey Pro League 2023/24 at the Lee Valley Hockey Stadium in Saturday night.

For India, Harmanpreet Singh (19') and Sukhjeet Singh (48') scored the goals, while for Germany, Gonzalo Peillat (2', 33') and Christopher Ruhr (10') were on target.

Germany were quick to get off the blocks on an attacking mode and put India on the backfoot. The reigning world Champions earned a PC early in the first quarter. Gonzalo Peillat (2') converted the penalty corner successfully to put Germany in the lead.

India then started pressing deep

inside Germany's circle with Hardik Singh and Gurjant Singh, combining to put pressure on the opposition's



However, it was Germany that doubled their lead as Christopher Ruhr (10') found the back of the net. The first quarter ended with Germany leading India by 2-0.

India started the second quarter well, matching toe to toe in the early exchanges. India earned a penalty corner within the first four minutes of the quarter.

Indian Captain Harmanpreet Singh (19') found the back of the net to bring India back in the game. Despite repeated attacks and putting constant pressure on the German defenders, India were unable to cover the deficit going into half-time.

High on confidence, India started the game aggressively after halftime, but the German defense continued to hold down the fort.

The third quarter saw plenty of action on both ends, but it was Germany, which extended its lead as Gonzalo Peillat was once again on the scoresheet (33') after he successfully converted the penalty corner.

Zampa, Australia's ace leg-spinner, struck again in his next over, dismissing the dangerous Buttler. England's middle order struggled to recover from these setbacks.

Miller, Baartman heroics seal victory for SA

NEW YORK: In the pulsating ambiance of the T20 World Cup 2024, David Miller emerged as the epitome of determination, guiding South Africa to a four-wicket conquest over the Netherlands. The showdown, held here on Saturday, unfolded as South Africa overcame adversity to snatch victory from the jaws of defeat.

The match commenced with South Africa facing an early setback as openers Quinton de Kock and skipper Aiden Markram were dismissed without troubling the scorers. At a precarious 12 for four, the Proteas seemed to be staring down the barrel of defeat.

However, in a display of sheer tenacity, a resolute partnership between Tristan Stubbs and the indomitable David Miller reignited South Africa's hopes. Their alliance,

worth 61 runs for the fifth wicket, served as a beacon of hope amidst the storm, propelling South Africa back into contention.

Though Stubbs and Miller fell in quick succession, it was Miller's composed innings, adorned with elegance and grit, that proved to be the decisive factor in South Africa's triumph. His unbeaten knock of 59 runs off 51 deliveries not only anchored the innings but also steered his team across the finish line in the face of daunting odds.

The narrative of the match, however, was not solely defined by Miller's heroics with the bat. South Africa's bowlers, spearheaded by the relentless Ottniel Baartman, orchestrated a masterful display of skill and precision, restricting the Netherlands to a modest total of 103 runs for nine wickets.

TCS launches

Economy to grow at 7.2 pc

MUMBAI: Exuding confidence that the Indian economy is likely to grow at 7.2 per cent in 2024-25, the Reserve Bank of India (RBI) said all sectors – agriculture, buoyancy in services sector, health, banks and business optimism, augur well for overall economic activity.

"Looking ahead, the forecast of above normal south-west monsoon by the India Meteorological Department (IMD) is expected to boost kharif production and replenish the reservoir levels. Strengthening agricultural sector activity is expected to boost rural consumption. On the other hand, sustained buovancy in services activity should continue to support urban consumption," RBI Governor

Shaktikanta Das said said while announcing the second bi-monthly monetary policy of the current fiscal 2024-25.He also stated that the healthy balance sheets of banks and corporates, government's continued thrust on capex, high capacity utilization, and business optimism augur well for investment activity. External demand should get a fillip from improving prospects of global trade.

"Taking all these factors into consideration, real GDP growth for 2024-25 is projected at 7.2 per cent with Q1 at 7.3 per cent; Q2 at 7.2 per cent; Q3 at 7.3 per cent; and Q4 at 7.2 per cent. The risks are evenly balanced," Das said. Equally important is good health of the global economyc and in this re-

gard, he said global growth is sustaining its momentum in 2024 and is likely to remain resilient, supported by rebound in global trade. Inflation is easing, but the final leg of this disinflation journey may be tough. Central banks remain

steadfast and data-dependent in their fight against inflation. Market expectations regarding the timing and pace of interest rate cuts are also changing with incoming data and central bank communication.

US dollar and sovereign bond yields remain range bound. While gold prices have surged on safe haven demand, equity markets have gained in both advanced and emerging market economies since the last MPC meeting.
