

28 new talathis to get appointment letters today

NASHIK: Appointment letters will be distributed to 28 newly selected talathis for villages outside the tribal areas of the district today, September 27. Following their appointment, these talathis will undergo a two-month training period under the guidance of senior talathis before assuming independent management responsibilities for their respective villages.

In the 2022-23 fiscal year, the government approved the filling of 173 talathi positions within the district. The recruitment process included a written examination conducted from August 17 to September 14 in Nashik. However, some candidates raised concerns regarding parallel reservation, leading to a court case. As a result, the district administration suspended the recruitment of 76 positions in the PESA area, out of the total 173 posts.

The recruitment process proceeded for 96 positions in the non-tribal (general) region, but 27 candidates failed to appear for document verification. To address this, a re-recruitment process was initiated for the 50 disqualified candidates, allowing them a month to rectify their statuses. Despite this, ten candidates were absent. Ultimately, out of the remaining 40 candidates, 28 from the general category will receive their appointment letters today.

Parallel reservation

In the initial phase of the recruitment process, 67 candidates were put in the waiting list. Reports for 21 candidates related to parallel reservation are still pending. Investigations regarding reservations for children of ex-servicemen, as well as those with disabilities, are ongoing, and these candidates will be appointed in due course.

Talathi recruitment was executed in the district. Following the first stage, those in the second stage will receive their appointment letters, which will enhance the administration of the villages.

Violence against women

Demand for action

NASHIK: Women office bearers of the Udhav Balasaheb Thackeray faction have in a statement submitted to Deputy Commissioner of Police Monika Raut has demanded to ensure the immediate registration of serious crimes related to violence against women, while also directing local police to prioritize the filing of such complaints.

The law and order situation in the state is currently concerning, with a disturbing rise in incidents of violence against women. Theoffice bearers highlighted that evasion in reporting these crimes is a troubling reality that must be addressed.

One particularly alarming case involved the sexual assault of two four-year-old girls at the prestigious Adarsh School in Badlapur. Recent months have seen a series of distressing events in Maharashtra, a state often regarded as progressive. Notable incidents include the assault of a minor girl by a schoolmate in a washroom at Pune and the harassment of six girls by a Zilla Parishad teacher in Kazikhed, along with similar cases in Koparkhairane and Uran in Navi Mumbai. These incidents underscore the police administration's failure to effectively prevent atrocities against women,.

Regrettably, local police stations appear hesitant to register complaints related to such serious offenses. Alarmingly, five cases of violence against women are reported every hour across the state. In 2023 alone, the statistics are staggering: 7,521 cases of rape, 9,698 cases of kidnapping, 169 instances of dowry-related violence, 11,226 cases of harassment by relatives, and 17,281 reports of molestation and sexual violence. Additionally, Mumbai has recorded 509 cases of child sexual abuse by the end of May 2024, the office bearers stated.

Despite the Maharashtra Police Force's global reputation, the delegation questioned the lack of urgency and sensitivity in investigating and responding to these serious incidents.

They demanded that there is a need for immediate action regarding crimes against women and insisted that local police be ordered to properly register all complaints

Shelke appointed in-charge of Indiranagar police station

NASHIK: Senior police inspector Ramdas Shelke has been appointed as the new in-charge of Indiranagar police station, following a transfer from the Nashik Road police station to the economic offences wing. He takes over from outgoing senior inspector Ashok Shermale, who is currently awaiting a new assignment.

Commissioner of Police Sandeep Karnik made the announcement regarding Shelke's appointment

This reshuffle comes as part of a broader series of transfers within the police department, prompted by the upcoming State Assembly elections.

As per Commissioner of Police Sandeep Karnik's directive, several police inspectors have been reassigned within the police commissionerate area. Ashok Shermale, previously the senior inspector

of Indiranagar, had been transferred from the office of the Director General of Police to Aurangabad but has appealed that decision. Consequently, Ramdas Shelke has stepped in to lead the Indiranagar police station

Additionally, police inspector Trupti Sonawane, who was appointed as secondary police inspector at Nashik Road police station from Gangapur police station last month, has been transferred again.

She has now been moved to to the economic offences wing.

Assistant inspector at Mhasrul police station Satyawan Pawar has been reappointed to Bhadrakali police station, while police inspector Vishwajit Jagtap, formerly with the state intelligence department, has taken on the role of secondary officer at Nashik Road police station.

Cyber criminals duped two of Rs 1.41 cr

NASHIK: In a sophisticated cyber fraud, criminals posing as officials claimed that multiple bank accounts had been opened using the victims' Aadhaar details, leading to a large-scale financial misappropriation under investigation by the Enforcement Directorate (ED). Using this ploy, the cyber criminals looted Rs 1.41 crore from two individuals in the city. A case has been registered at the Cyber Police Station.

According to a complaint filed by a woman, the criminals contacted her father between August 23 and September 20 via the internet and phone calls. They intimidated him with threats of ED action, coercing him into providing his bank account details. The fraudsters then transferred Rs 1.31 crore from his account into various other accounts.

In a similar incident, a young girl from the city was also deceived. The criminals managed to withdraw Rs 10.23 lakh from her bank account.

A case has been registered against the individuals who contacted the victims, as well as the account holders in whose names the stolen money was deposited.

Cyber criminals Doctor threatens patient

NASHIK: A doctor initially agreed to compensate a migrant woman for providing incorrect medical treatment but later reneged on his promise, verbally abused her, and issued threats.

According to a complaint filed by Soumya Shasidharan Nair, a resident of Andhra Pradesh, she was admitted to Santosh Multispeciality Hospital near Pournima Bus Stop in August 2023 for gallstone surgery. During the procedure, Dr. Santosh Rawlani allegedly acted negligently, damaging her blood vessel and cutting her bile duct. Despite the severity of the injury, Dr. Rawlani concealed the mistake from Soumya.

As her condition worsened, Soumya sought further treatment at private hospitals in Nashik and Pune. When she confronted Dr. Rawlani about the botched surgery, he admitted to the mistake and agreed to pay her Rs. 11 lakh in compensation. However, when Soumya later approached him for the payment, Dr. Rawlani verbally abused her and refused to pay the compensation.

Threat of violence

The situation escalated when Dr. Rawlani allegedly threatened Soumya, saying, "Go anywhere, I won't give you a single rupee, and I won't let you stay in Maharashtra either." He also reportedly attempted to assault Soumya's father, Shasidharan Nair. A case in connection with has been filed against Dr. Rawlani at Bhadrakali police station.

Argument over Navratri celebration

Shots fired in air at Jail Road

NASHIK: A heated argument among members of a mitra mandal formed to celebrate Navratri festival escalated when an office-bearer of a political party fired shots in the air using a country-made revolver. The incident occurred near the Shivshakti Nagar water tank garden in Model Colony, Jail Road, at around 11 p.m. on September 23. According to the police, one of the four suspects involved has been arrested, and the incident stemmed from a personal dispute among friends.

The arrested suspect has been identified as Nitin Rajendra Barve, while the other suspects, Santosh Pillay, his friend Bhagwat, and an unidentified individual, are still at large. The police are searching for them.

According to the complaint filed by Suyog Khanderao Gunjal (32), a resident of Manikmoti Society in Model Colony, he and the suspects are long-time friends. Gunjal, who was elected president of the Vasant Vihar Mitra Mandal for this year's Navratri celebrations, had a disagreement with Barve over the festival preparations. On the evening of September 22, Gunjal was sitting near the garden when he received a call from Barve. During their conversation, Gunjal expressed frustration, saying that he was responsible for all the Navratri preparations but no one else was helping. Barve mentioned that they had approached Santosh Pillay for a donation, to which Gunjal responded that he didn't care about Pillay's donation and no longer wished to be involved in the festival or remain president.

Following this argument, Barve and the other suspects arrived at the garden in a car around 11 p.m. They asked Gunjal to join them, but he refused and returned home. Shortly afterward, the suspects reportedly drove to the garden and fired shots into the air after an argument under influence of alcohol. Gunjal filed a formal complaint in this regard with the Nashik Road police, who are now investigating the case. While some suspects claim that the shots were fired using an air gun, the investigation is ongoing to determine the exact nature of the firearm used.
