Ankita had made a first-round exit in the singles but made up for the disappointment by bagging the doubles title with Naikhta, winning 6-4 3-6 10-8 in one hour and 42 minutes at the DLTA Complex.

Before title victory, Ankita last won a doubles trophy at the Kashiwa event in Japan in April 2024 when she partnered

## Hyderabad, Bengaluru split points

**HYDERABAD:** Hyderabad FC and Bengaluru

FC played out a 1-1 draw at the GMC Balayogi Athletic Stadium in the Indian Super League (ISL) match. Devendra Murgaonkar's first-half strike was neutralised by Sunil Chhetri in the second essay of the match. Chhetri, 40, touched the 10-goal mark for the second time in his ISL career, after having netted 14 times in

the 2017-18 campaign. Bengaluru FC held 62.4% of the possession, but had a solitary shot on target, which Chhetri converted to get them a point out of this match.

The opening phase of the game was slightly cagey as both teams struggled to create clear chances. Bengaluru FC attempted to break past the Hyderabad FC defensive line but were not exactly cohesive in their moves. Chhetri was flagged offside twice in the opening 20 minutes.

The home side retaliated soon afterwards, as they embarked on a positive phase of play with Allan Paulista winning a freekick in the attacking half. Ramhlunchhunga served a pinpoint cross for Devendra Murgaonkar, who was positioned at the centre of the 18-yard box and headed the ball into the bottom right corner to get the lead in the 21st minute.

Murgaonkar operated sharply in the offensive, making the right moves in the Bengaluru FC box to cause troubles to the visitors. Twelve minutes after his goal, Joseph Sunny picked the attacker in a spot on the right side of the penalty area. Murgaonkar did well to exert power behind his shot from that angle, but the ball was saved by Gurpreet Singh Sandhu on the top right corner.

## Men's winner won over \$3,000

TRONDHEIM: As a reward for finishing first in qualifying at a ski jumping World Cup event, organisers presented the male winner Jan Hearl with 3,000 Swiss francs (\$3,290), and the female winner Selina Freitag with towels and sham-

"I received a partner bag with shower gel and shampoo and four hand towels," Freitag told German TV channel BR24 after she finished first in qualifying at the Two Nights Tournament in Garmisch-Partenkirchen, Germany on December 30. "We unfortunately didn't have a spare five hundred (euros) or so."

Skiing's governing body, FIS, told CNN that female winners of qualifying events don't receive prize money like their male counterparts, according to a CNN report.

They said the gift also included a voucher for a weekend of wellness treatments and "was certainly well intentioned, but it is understandable that it may have generated frustration and given a bad impression if seen as formal compensation for the victory. This was not the case."

FIS added that women's ski jumping is still a relatively new sport with less spectator interest and marketing revenues than its male counterpart, and consequently has less prize money available. CNN has contacted the event organiser for comment too.

The discrepancy in prize money available "highlights the inequalities that still exist in sport in sport to this day," Her Sport, an advocacy group for gender equality in sport, posted on X.

### MSMEs lacking required infrastructure: IndusLaw

NEW DELHI: IndusLaw, a law firm, has asked the government that it should ensure that it provides sufficient time implementation for the Invoice Management System (IMS) due to sigtechnological challenges being faced by MSME retailers.

While the introduction of IMS was designed to strengthen the Goods and Service Tax (GST) compliance process, several unresolved technical and operational issues have risked undermining its successful rollout among small sellers and are posing several challenges, according to IndusLaw, India's top law firm.

(GSTN) issued an advisory on 3 September 2024 to introduce the IMS functionality on the GST portal from 1 October 2024 onwards. The introduction of the IMS was expected to facilitate transparency between recipients and suppliers and streamline the reconciliation of Input Tax Credit (ITC), which has been a challenging process since the introduction of GST, IndusLaw said in a statement.Post the initial rollout of the IMS, the API versions for recipient side were released only in mid-October. The government's efforts to streamline compliance through IMS have left small businesses with

insufficient preparation time. This narrow window has left MSMEs struggling to implement essential changes, including modifications to accounting software, overhauls of Accounts Payable (AP) modules, and updates to technological infrastructure.

Commenting on the challenges faces MSME retailers, Shashi Mathews, Partner, Indus-Law, stated, "Unlike earlier GST reforms, such as e-invoicing, which were introduced gradually over several months or years, the accelerated timeline for IMS does not provide businesses the necessary time to adapt. Therefore, we recommend either ex-

tending the implementation timeline or addressing these technical gaps to ensure that businesses, particularly those with high transaction volumes, can comply without undue hardship. A phased rollout would allow for smoother adoption and maximize the benefits of IMS."

significant Another challenge being highlighted is the delay in release of APIs for the supplier dashboard limiting the ability of businesses to view actions taken by their customers on IMS. Without robust technological infrastructure, even businesses ready to comply with IMS face operational roadblocks.
